

# GLEBE COMMUNITY CARE CENTRE

A pilot study concerning the provision of community care was inaugurated towards the end of 1972 by the Royal Prince Alfred, Balmain and Callan Park hospitals. The Glebe Community Care Centre is Hereford St, Glebe for the people of Glebe, Ultimo, Pyrmont, Forest Lodge and Annan--dale. People who need any kind of paramedical or social help may be referred to the centre by their own doctor. Indeed, any person who feels he or she would benefit by the services offered by the Community Care Centre may ring or call at the Centre. There is a Doctor Administrator and social workers, occupational therapists, a physio--therapist, mental health workers, community nurses from the Sydney Home Nursing Service, a part time speech therapist, a part time dictician and a part time psychiatrist, all working in together. The enthusiasm, involvement and close co-operation of the staff at the centre is most impressive.

Regular ward rounds are made in the local hospitals, seeing any of the patients from these areas. Follow up visits are made to houses and everything possible is done to help. Cases include deserted wives, unmarried mothers, people with weight problems, old people or people on their own who need attention, people in need of advice on social services - in fact, any person with a problem. Well over 900 people have been cared for over 15 months, with continuing care if necessary.

The Centre works with all agencies in the area - The Woolley Centre, Baby Health Clinic, general practitioners, The Smith Family, etc..

There is a monthly social morning at the Centre run by the Red Cross for patients and their friends. They have music, or a film, or some other interest-ing programme for a couple of hours, and are usually given lifts to and from the Centre. Quite often this is the only outing some of the people have.

All in all, the Community Care Centre is currently providing an unique service, encompassing any physical, mental or social problem one could put forward, and dealing with that problem sympathetically and constructively.

In spite of 1,673 signatures on a petition,
54 letters of objection (including one from Hawaii)
and one telegram (from London) the atrocious Aust-ralian Portland Cement bulk terminal proposal for
the bottom of Ferry Road has not yet been decided
upon by Leichhardt Council. The delay in reaching
a conclusion on this matter is not a reflection on
the Council but an indication of the importance of
the decision.

The State Government considers Blackwattle and Rozelle Bays as ideal for heavy industrial and container shipping activity (particularly once the completion of the North-Western Freeway allows the removal of Glebe Island Bridge).

As councils in N.S.W. are considered nuisances to unlimited development, the Land and Valuation Court has been replaced by a Local Government Appeals Tribunal. (The appeals are one-way; residents have no access to this Tribunal). There is a fear that, unless we really make our voices heard, a disapproval of the proposal by Council would be eventually overriden by the Tri-bunal.

Another thing that could happen if Council disapproved the application is a change of zoning by the Minister to "Special Port Purposes" as is the Pioneer Cement site in Bridge Road. Council would have no control over such a zoning. Such zoning allows industry complete disregard of nearby residents as is the case with Millers Coal in Bridge Rd who can operate at 3 a.m. at a noise level which would not be tolerated in the middle of the day under Council control.

The Sydney Region Outline Flan states that, "Sydney shall remain Australia's greatest port". While this determination to always remain greater than Melbourne is curious, it has surely been demonstrated with the Glebe Island container fiascos that these bays, to the immediate West of the city, are highly unsuitable for such massive industrialisation. The streets to the waterfront are too steep and narrow. The bays are too narrow for large ships (the Liza Miller did extensive damage to two trawlers recently while trying to turn in Blackwattle Bay).

It is very important that all members of the Glebe Society, assuming they wish Glebe to remain a predominantly residential suburb, show their disapproval of this 100 ft high waterfront proposal and any suggestion that future proposals of such magnitude and potential destruction to amenity be even considered.

We call on members to make a special effort to be present, with friends and neighbours, at a Council Works Inspection at the corner of Taylor St and Ferry Rd at 10.00 a.m. Saturday 4th May 1974. HOUSE OF REPRESENTATIVES SELECT COMMITTEE ON ROAD SAFETY

The Glebe Society gave evidence to the committee on 15th February 1974.

Members may wonder what the Society would have to say about Road Safety, but an aspect of the committee's study was the effect of freeway const—ruction on road safety. The pro-freeway lobby has been stating that 200 lives per year would have been saved in Sydney if the D.M.R.'s freeway proposals were already completed.

Our evidence questioned the assumptions behind such a statement, such as; freeways would not increase car usage, speed, length of journey or number of trips. The pro-freeway lobby also compared safety on freeways (which exclude ped-estrians and pedal cyclists) with safety on normal roads which include all types of transportation. We were also able to include an attack on the radial nature of Sydney's freeway proposals.

The committee's report was released recently and our comments were well heard (Financial Review 26/4/74). In spite of many contributions from sub--missions concentrating on "concrete" solutions to the road safety problem, the committee "managed to remain unimpressed by the contribution of the urban freeway."


