WHAT THE COMMITTEE DID

1. Leichhardt Council has imposed a month's ban on its use of 2,4,5-T. The Society's response will depend on further Council decisions.
2. The idea of a Glebe Fair along the lines of the Queen Street Fair is being considered. A general decision will be made soon. Much work is involved and the Committee would appreciate help if we go ahead.
3. Tony Larkum is to co-ordinate the actions of the Glebe Society with our "sister" Societies - Balmain, Annandale and Leichhardt) in regard to the upkeep of the municipality's minimal green areas by Leichhardt Council, who could do more for the parks in terms of trees, plants and facilities.
4. Traffic in certain Glebe streets was discussed. Streets such as St. Johns Road, Bridge Road, Wigram Road, Ferry Road, Forsyth Street. The committee is planning to approach the appropriate authorities to reduce the noise and volume of traffic in these essentially residential streets, which are becoming less safe and more intolerable day by day.
5. John Buckingham reported that 60 residents' letters of protest about the re-leasing of the old Steetely's site to a scaffolding storage firm had been sent to Messrs. Landa, Hills and Rodwell, and that 178 petition signatures to Mayor Rodwell and 237 to Mr. Landa had been also forwarded.
6. The committee reiterated its 1978 decision to support the transfer of the Glebe ward to the City of Sydney Council if this becomes a possibility.

NEW MEMBERSHIP AND OLD MEMBERSHIP

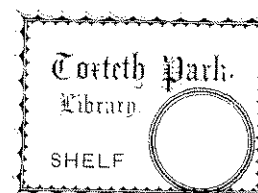

FREEDOM OF INFORMATION

A substantial report on the Freedom of Information Bill 1978 was tabled in Federal Parliament at the end of 1979, by Senator Alan Missen, chairman of the Senate Standing Committee on Constitutional and Legal Affairs. The recommendations in the report would, if adopted, result in a much more effective piece of legislation than that originally drafted.

This legislation is of importance to groups such as the Glebe Society since the essence of the Bill is to make government documents and the operations of government and governmental agencies accessible to members of the public. In the past the Society has, at State and Local level, had great difficulty in obtaining information from bodies such as the Maritime Services Board or the Department of Main Roads on matters affecting this community.

If legislation is enacted at the federal level, this will add weight to the efforts being at state level to achieve similar legislation. This was envisaged in the Wilenski report some time ago on the operations of State government departments.

Individual members of the Society who are interested in moves for this kind of legislation at both state and federal level might care to indicate their support of the federal legislative proposals, as amended by the Standing Committee report, to their local federal MP or to a State Senator, such as Senator Chris. Puplick, a member of the Senate Committee, and of efforts in the state area by becoming members of the N.S.W. Freedom of Information Council (subscription \$10 for individuals, \$25 for associations, or \$2 for students, pensioners, or 'the broke' - to P.O. Box 753, Manly, with your name, address and telephone number).

COAL LOADER WAKE

A year ago on the 20th February, a silent demonstration was held outside Parliament House by supporters of CLOG (The Coal Loader Opposition Group) amongst whom were many Glebe residents. The Premier, Mr. Wran received a deputation and promised to meet with representatives of CLOG, within three weeks. After a year of waiting, while the construction of the upgraded Coal Loader has gone ahead, it was decided to hold a silent wake outside Parliament House on the anniversary date. Unfortunately the rail strike and short-notice kept many would-be protesters away. Nevertheless an important point was made. Dust from the old Coal Loader exceeded World Health Organisation recommended levels for over 1 kilometer around (which covers a considerable area of Glebe) and residents have been given no assurance that the new Coal Loader will be any better (it could be worse).

PARKS OR TRUCKS?

The three-year lease obtained by S.G.B. Building Equipment Pty. Ltd., from the Maritime Services Board, over 27-45 Federal Road, Glebe (Steetley Industries site) has annoyed many residents. The already chaotic traffic conditions of Federal Road must worsen, as the scaffolding equipment and formwork stored on the site will be sent to their destination by road transport. (Brace up for a greater 6 a.m. gear-grinding onslaught you Eglinton, Northcote and Glebe Point Roaders!)

Far worse for the Glebe community at large is the effect the loss of this site (fronting Rozelle Bay and Johnston's Creek stormwater channel) has on Glebe's hoped-for Marine Park. We clearly understood that the water-front sites along Federal Road, as they became available, would be an integral part of a waterfront parkland extending from Black Wattle Bay Park around to Johnston's Creek (and beyond, to Annandale). The local politicians had the same understanding and were as flabbergasted as we were to hear of the lease.

The Maritime Services Board has been totally unrelenting on the matter and offers no concessions even at the end of the three-year lease. The Board has advised the Glebe Society that "the waterfront area fronting Rozelle Bay between Johnston Creek stormwater channel and Pope Pius VI reserve should remain as at present for Port purposes".

At this juncture, it seems reasonable to remind members that Glebe has only 40% of the parkland that is regarded as "adequate" for its size and population, and only an insignificant amount of that is waterfront parkland. Further, Glebe is already over-endowed with problems caused by trucks, and the proposed usage of the site will serve only to exacerbate the situation.

Contact with residents in the area most immediately affected, revealed how bitter they were at the proposal. Fortunately it was not just impotent rage. Letters were written and petitions were signed. The Society passed on 60 letters to Paul Landa (Minister for Planning and Environment); 60 letters to Pat Hills (our local member); 60 letters to Les Rodwell (Mayor of Leichhardt), and a further 237 petition signatures to Landa. Here I stress, we canvassed only the area immediately affected by the proposed use of the site. Further, in addition to the totals given above, many people canvassed indicated they would be sending letters of protest direct to the politicians.

Will the will of the people or the will of the bureaucrats prevail? If persistence is worth anything, we'll win. We intend pursuing this one constantly. A win is essential or the marine park is lost forever.

The following letter addressed to the Planning Convenor, The Glebe Society, from the Town Clerk, The Council of the Municipality of Leichhardt, has only just arrived.

The Society is disappointed with the decision and there may be more news next Bulletin.

"Dear Sir/Madam,

Proposed New Grandstand and Facilities at Wentworth Park, Glebe.

Reference is made to Council's letter dated 10th August, 1979, regarding your objection to the Development Application lodged by Warren Samut Architects Pty. Limited, on behalf of the Trustees of Wentworth Park and the New South Wales National Coursing Association Limited, for permission to construct a new grandstand and facilities at Wentworth Park, Glebe.

This matter was again considered by Council at its meeting held on 5th February, 1980, following receipt of advice from the New South Wales Planning and Environment Commission, when it was decided that as the appropriate alteration to I.D.O. No. 27, has been made, and the Commission has issued its concurrence to the proposal, Council is prepared to approve the application subject to the conditions listed in the Consultant Town Planner's Report and to the requirements of Council's Health and Building Department."

A GLEBE PASSENGER RAILWAY

The "Telegraph" on Tues. 12th February, ran an article on the possibility of upgrading the goods railway through Glebe into a passenger line. The railway runs from Redfern through Railway Square, Wentworth Park, Glebe, Lilyfield and Leichhardt to Summer Hill. Much of the article was based on the Glebe Society Monograph No. 2, prepared by John Gerofi and Jim Coombs in 1976. Channel 9 followed this up with an item on the 6.30 news.

With the widespread interest in alternative transport systems to cars and buses, the Glebe Society's spadework is paying dividends. However with changing technology and ideas, the Glebe Society needs to review its railway proposal. Any one interested?

Chemical Damp Coursing

In the Dec. issue an extract from "Restoring Old Houses" by Ian Evans appeared dealing with chemical damp courses.

Experience and enquiries since, indicate that a drill bit size of 12 to 15 mm should be used. Also Drisil 48 is available from Ajax Chemicals, 390 Marion St. Bankstown.

There is an amazing difference in price between the small half litre container and the next size which contains at least eight times more. The half litre is over \$15, whereas a 4 kg. container is \$37. The best thing to do is to share the cost with at least one other householder.

By the way, there are at least two litres left over and available at cost from Eric Sandblom, 660-6593.

Drisil 48 is diluted, 10 to 1 with white spirit or mineral turps.
