Trees


The Society would like to congratulate the Council on the tree planting proposals for Foss Street. However there are several gaps in the treescape of St. John's Road, and we believe the Council should fill these gaps with appropriate plantings. The Society also recommends that residents weed the footpaths and tree plantings in their streets outside their own houses. This reduces the risk of Council using poisonous weed-killers to get rid of weeds.

LEICHHARDT MUNICIPAL COUNCIL DRAFT LOCAL ENVIRONMENTAL PLAN - RESIDENTIAL DENSITIES.

Earlier this month Leichhardt Council held a meeting to present their Draft Local Environmental Plan - Residential Densities. The Department of Environment and Planning in a letter dated 14.4.83 had confirmed that a general density control of 175 p.p.ha throughout the Municipality would be acceptable provided that larger sites (over 1000 sm) be capable of development to 200 p.p.ha, and a smaller number of sites (already developed above these densities) be zoned 225 p.p.ha. Those sites have already been developed or have development approval.

While the Plan does not meet Council's objectives in the June 1981 draft plan already rejected by the Dept., it is the best that can be achieved at this time and is the result of extensive research and forceful argument by Council Officers. The 175 ppha. zone allows and encourages 2-storey town house built form in preference to larger 3-storey home unit forms likely in 2250 ppha. zones & represents a reduction to "upper limit" densities as well as a disincentive to redevelopment of typical allotments. Combined with controls that will be imposed by the Development Control Plan Council considers it could be confident that the revised densities & the Development Control Plan would provide an adequate safequard against incompatible and out of scale development which is the primaty objective of the Council.

The whole of Glebe will be designated a Conservation area on the Council's new Plan and therefore the Conservation controls will be effective in Glebe. Unfortunately other parts of the Municipality are much less well treated and it is disappointing that the Dept. of Planning & Environment has not sought resident participation and is imposing this plan on the Municipality.

Once the Dept. of Planning & Environment give permission for the Plan to be exhibited then the Exhibited Plan can be taken into account in a Court if the Council wishes to oppose a development proposal.

Apart from the proposal to allow a density of 200 ppha on large sites, the density proposals are generally in line with the Glebe Society's recommendations made in 1979.

THE GREAT GLEBE STEAM TRAIN RIDE

Ron Best, one of our members, was the instigator, promoter and organiser of the Train Ride and on behalf of the Society - our very grateful thanks for all your work. Our thanks also to the NSW Rail Transport Museum for allowing us the use of the train and other facilities.

The train - 9 cars built about 1910 were relics of pre-electrification Sydney suburban operations - was pulled by Locomotive 5461, built at Everleigh Locomotive Works about 1916 and which has been restored by the Museum's volunteers.

The journey started from Redfern in order to gain access to Darling Harbour. Did you know that at Redfern there is the Engine Dive, the line running in a tunnel beneath platform 1. This line allows locomotives and empty trains from Eveleigh depot to reach Sydney station without crossing all ten tracks on the level? The Museum supplied a pamphlet with enought interesting material to fill a complete bulletin.

The first part of the journey was particularly interesting through Darling Harbour and over the viaduct across Wentworth Park and into the 800 metre Glebe Tunnel- lights switched on and smoke billowing back and into the carriages.

There were plenty of spectators along the track, cameras at the ready, waving us along as the engine chuffed and the whistle announced our arrival.

For the Society members, their kids and grandkids, friends and the train afficionados it was all great fun.

BUT, the train ride also had its other purpose, and that was to again draw attention to the fact that part of the route could be used as part of a Light Rail system. The section is that from the goodsyard at Lilyfield through to the new Entertainment Centre in Haymarket. It would be linked with unused tunnels in the city and former tram reservations in the eastern suburbs to create a light rail network joining the Opera House to Balmain, Abbotsford, Coogee, Maroubra and la Perouse. In view of the plans announced for Darling Harbour the Light Rail Association consider that the need for such a line is great and if the goods line is not used in this way, it will probably be closed permanently as the Darling Harbour Goods Yard is moved out.

GLEBE SOCIETY BIRTHDAY PARTY

242 St. John's Road, Glebe. 23 July, 1983 (evening)

Chris Jones and Patti Graham, who live in this charming old terrace have generously invited the Society to hold our Birthday Party in their home.

No.242 was built in 1873 by Mr William Henry Robey, and is a fine example of post regency architecture. It was built from sandstone blocks cut from an adjacent block of land by Mr Robey and his brother-in-law.

Mr Robey died in 1921 at the age of of 86 after a colourful early life and distinction in public office. Having joined the Royal Navy at 16, he was later shipwrecked twice during the Crimean War. Towards the end of the 1850's he arrived in Australia and headed for the goldfields. Eventually he settled in Glebe where he lived for 50 years, and was in business as a master carrier. For 23 years he was an alderman on Glebe Council and was superintendent of Glebe Rd. Sunday School for 3 years. He had 14 children, 10 of whom survived his death.

Neglect of No.242 began in the 1960s and continued until 1980. During this period the iron lace was stolen from the front verandah and a similar veranda at the rear of the house was destroyed. At one stage the house was rented as office space and was repeatedly broken into by vandals who smashed windows and wrecked the fireplaces.

Mr Vince Johnson bought the house in 1980 and has since restored it.

WEDNESDAY 22 JUNE


