CITY WEST LINK ROAD

<u>CITY WEST ROAD - ENVIRONMENTAL IMPACT</u> STATEMENT

Dear Sir,

The Society has closely examined the above Impact Statement and wishes to make a submission in respect to it.

Despite some serious deficiencies in the Impact Statement, the Society welcomes the City West Link proposal as presenting the possibility of better traffic management in Glebe. This will only occur. however, if the matters set out in submission are properly addressed. The main issues are considered to be as follows:

- (a) Glebe is a clearly defined, compact, largely residential area and in line with the most enlightened planning ought to be treated as a neighbourhood where all unnecessary through traffic is excluded.
- (b) The total area of Glebe is an important heritage area Classified by the National Trust, Listed on the National Estate Register and recognised in the Local Planning Scheme for Leichhardt Municipality. Experience both here and overseas suggests that for any confidence to be given to heritage conservation on a large scale through traffic needs to be excluded.
- (c) There are six major entry points to Glebe: from the west via Wigram Road, from the north via the Crescent, from the east via Pyrmont. Bridge Road and St. Johns Road and from Parramatta Road via Glebe Point Road, Derwent Street, Ross Street and Pyrmont Bridge Road. One of the major points of concern is the through traffic along the Crescent and the current City West Link Road proposal directly relates to facilitating

north south traffic through Glebe provided by the proposed grade separated interchange at the junction of the City West Link Roadand the Crescent. The Society also strongly opposes the proposed truck access proposed from the Rozelle Bay container terminal to the Crescent. The details of the Society's objections and suggested changes are made in the attached submission.

(d) While the City West Link proposal is aimed at providing the capacity for reducing through traffic in residential areas this aim will not be achieved unless the Department of Main Roads takes active steps to dissuade traffic from local streets; it is simply insufficient to say, as the Environmental Impact Statement does, that the City West Link should reduce through traffic in residential streets.



- (e) Traffic changes made in recent years by the Department of Main Roads have increased the amount of through traffic occuring in the Glebe area. The most obvious recent example of this is St. Johns Road which has now become an alternative city route because of the installation of traffic lights at the Ross Street intersection. Recent improvements to the Crescent have significantly increased the traffic flow into both Wigram Road and St. Johns Road neither of which are suitable for through traffic use.
- (f) Until the completion of the Glebe Island Bridge any potential relief of traffic in Glebe will not occur. The Society absolutely opposes the completion of the City West Link Road unless this is done concurrently with the construction of the Glebe Island Bridge.
- (g) The Society believes that the Department in conjunction with Leichhardt Municipal Council is responsible for taking action to stop unneccessary through traffic in Glebe. Such action should be taken now and not be dependent on any other factors. The Society feels very strongly about this matter. The immediate concerns are Wigram Road and St. Johns Road, both of which lead off the Crescent/Ross Street, an arterial Road for which the Department has responsibility. The immediate action proposed is that the Department install no left turn signs (exceptbuses) from the Crescent/Ross Street into these streets in the morning peak and no right turn out in the afternoon peak. Complementary signs would also need to be placed at the eastern end of both these roads to stop evening peak traffic. Within one year it ought to be possible to design and erect low cost structural controls (e.g. landscaped chicanes) at these and related points to dissuade through traffic while allowing local, emergency vehicle and bus usage. If the Department of Main Roads is not prepared to adequately address these issues the current traffic situation in Glebe, which is admitted by the Environmental Impact Statement to be serious, will become horrendous. The positive measures suggested by the Society can be achieved in the short term at no construction cost and without disruption to existing local traffice in the area.

LYNDHURST VISITORS BOOK

Letter received from Peter Watts, Director of Lyndhurst, thanking society members for the gift of the visitors book, it is very much appreciated.

If adequately addressed the residents of Glebe will applaude the DEpartment and the Government for its sensible position on the matter. If not the residents of Glebe will again lose out for the lack of what after all is very little consideration. At this stage the Society is prepared to overlook the serious shortcomings of the E.I.S. in terms of the requirements of the Environmental Planning and Assessment Act but only if the Department of Main Roads is prepared to consult and sensibly provide for the adequate protection of the Glebe area. If it does not the Society plans to use all methods at its disposal including legal action before the Land and Environment Court.

Finally I draw your attention to a recent letter to you from the Society pointing out that while the E.I.S. lists the Society in Appendix C as a body with which consultation has taken place this was not the case. In this respect the Society calls on the Department to meet with its representatives with a view to practical measures being discussed and implemented immediately and to provide a smooth path for the introduction of the City West Link.
