

At the Building and Development Committee meeting on 20th May, Leichhardt Council deferred its decision pending a further report. The Society is very concerned, since Council's Planning Department strongly recommended refusal of the application on both planning and heritage grounds. Graham Fenwick and Terry Ginn have made great efforts to save these remarkable Edwardian shops and the Society has helped them to obtain about 200 requests from residents to retain the shops. Don Ellsmore and Max Solling have also made major contributions.

Please ensure that the efforts of all these people are not wasted by making your support for preservation known to Leichhardt Council and the media.

#### NEW COMMITTEE MEMBER

Peter O'Gorman has been co-opted onto the Committee. Peter is helping Mike Curtis with the book-keeping for the next few Appeaks and we are hoping that we have found અr new Treasurer.

I interviewed Ross Barker, Deputy Head of Administration at the Children's Hospital on 27 May. The piledriving which has been shattering the peace of Forest Lodge is the Water Board repairing the conduit pipe of Orphan School Creek, which flows underground until its junction with Johnston's Creek. An overenthusiastic bulldozer driver pushed a large volume of fill onto the conduit in the process of constructing an ambulance bay and the Water Board claims the conduit was damaged. After repairs are made, the ambulance bay will have to be constructed on fill, as before.

The land swap between Leichhardt Council and the Hospital to make Orphan School Creek Park a possibliity has been delayed by the legal impediments to Council surrendering gazetted parkland for any purpose, according to Mr. Barker.

The Hospital's master plan is still at a rudimentary stage. The aim is to consolidate
the main site by building a service block and
relocating stores and workshops. The old
Myers warehouse on Booth Street is to become
a multi-storey car park. The Hospital is
considering a town house development for vacant land it owns in Forest Lodge and is aware
that this must be compatible with existing
housing. It has consulted developers, but no
firm plans, for this or anything else, have
been drawn. Don't hold your breath.



#### WIGRAM ROAD - MONEY DOWN THE DRAIN

At their meeting of 12th May, Leichhardt Council decided to proceed, in the words of the Municipal Engineer's report, to 'provide for the replacement of 980 metres of old stone kerb with new concrete kerb and gutter both sides of Wigram Road from Ross Street to Glebe Point Road, and including ancillary drainage improvements, footpath reconstruction in concrete and road pavement resheeting'.

The source of funds for this work is stated to be the Federal Government's Australian Land Transport Programme (Urban Local Roads Programme). The initial grant of \$98,000 was apparently approved on the recommendation of the DMR in January this year, despite protests from the Society and the National Trust. The total cost of the proposed work is believed to be about \$400,000, of which the remaining \$300,000

odd would be sought over the next two years.

The Society contacted the National Trust to inform them of Council's decision and on the advice of the Trust requested a Conservation Order from the NSW Heritage Council. At the same time the Traffic sub-committee distributed 600 flyers informing residents and asking them for their help, and also explained the situation to the media.

On the afternoon of Thursday 21 May the project signs were removed from Wigram Road and the DMR has since requested a meeting with the Glebe Society.

OBJECTIONS - the Society's objections are of two kinds:

- 1. The project is unnecessary, of extremely low priority and trivial in relation to its huge expense. Wigram Road is not perfect, but its major problem, in common with most of Glebe. is an excessive volume of commuter traffic. If Federal money is to be spent in the area, it should be directed to a worthwhile goal; a traffic plan for Glebe that limits the overflow of through traffic into local roads and improves safety for pedestrians and motorists.
- 2. The sandstone blocks forming the kerbs date from 1887 and are an integral part of the the picturesque Victorian street—scape of this part of Wigram Road, which forms part of the Glebe Conservation area. Any upgrading of Wigram Road involves not only damage to its heritage value but also a further deterioration of the environment, which is already detrimentally affected by the traffic.

Both at Parliament House, Canberra, ACT 2600. The Heritage Branch of the Department of Environment and Planning has recommended the retention of three of the houses on Stride's Yard. They are, in descending order of importance, The Retreat (No 53, built 1853, stone post-Regency), Drayton Lodge (NO 51b, built 1872 by Ambrose Thornley Snr) and Florence Villa (No 49, built 1876 by Ambrose Thornley Jnr).

The Committee has pointed out the need for a Community Centre and for the future use of Bellevue/Venetia to be considered in conjunction with the other houses. A Community Centre would probably need the co-operation of Leichhardt Council and the Society's original proposal, drawn up in consultation with Leichhardt Planning department, was rejected by the Glebe aldermen.

The waterfront section of Stride's Yard was gazetted as open space on March 16 and the incorporation of this area as waterfront park joining the two sections of Blackwattle Bay Park also depends on Leichhardt Council, who may need prompting.

#### ROADS 2000

One cause for rejoicing in this document is the deletion of the County Road Reservation along the Johnston's Creek Valley. We do not want it replaced by a container access road that feeds heavy vehicles into Glebe and Annandale.

# Stop Wentworth Park being used as a carpark, demand residents

Inner-city residents have called on the State Government to restore Wentworth Park as a recreational area, rather than allow it to be used as a carpark by visitors to Darling Harbour.

The park has increasingly been used for parking, particularly during public transport strikes.

Now the 500 members of the Glebe Society — a residents', action group interested in local history — fear the State Government is planning to allow Darling Harbour visitors to leave their cars in Wentworth Park until its own carparks are completed.

The 1,500 parking spaces in the casino proposal the State Government is still considering will not

be finished in 1988.

A spokesman for the Minister for Public Works, Mr Brereton, said that Wentworth Park would only be used for parking on special occasions. This would include weekends, particularly when the First Fleet re-enactment ships and the Tall Ships came to the harbour.

By 1988 there would be 5,000 parking spaces in Darling Harbour, Mr Brereton said, and these would only rarely need to be supplemented by places such as Wentworth Park.

But residents say enough is enough, and that it is time the park was returned to the people.

The president of the Glebe Society, Ms Edwina Doe, said the Government was focusing all its attention on Darling Harbour and ignoring other potentially beautiful parks.

Over the past 50 years, the park had increasingly been used for "vested interests" which showed little concern for the local community.

In 1880, this paper described the park as "the most attractive and beautiful of our recreation grounds, second only to the Botanic Gardens".

But then came the encroachments — greyhound racing began at Wentworth Park in 1939.

Ms Doe said letters had already been written to the State Government, but it had not guaranteed to leave the park alone. She said residents would begin collecting signatures for a petition.

#### REPORT TO RESIDENTS

Leichhardt Council is distributing a report this year including some comment on controversial projects that are still taking place.

Members should note among other things the huge rise in Capital Acquisition (P9). Currently Leichhardt Council is proposing to demolish two of its properties for a carpark in Leichhardt.
